The Bridge Youth Service (TBYS) plays a key role across the Goulburn Valley in youth support and advocacy. With offices located in Shepparton, Seymour and Wallan, TBYS delivers services and supports to young people and their families with a particular focus on those from marginalized and/or disadvantaged backgrounds but with a philosophy that includes the provision of services to all young people. TBYS offers a range of programs funded by government, private foundations and the local community. Programs focus on a diversity of issues and services include placement prevention, family reconciliation, family mediation, antenatal, parenting, housing support, mentoring and education support. #### **Role Purpose**

The purpose of this role is to provide intensive support to young people around a range of issues including substance use, mental health, housing, relationships, employment/education, parenting, independent living skills, etc within a therapeutic program.

# Responsibilities

A combination of these will be required, dependant on the young person.

- The provision of a developmentally appropriate service to vulnerable young people in the Mitchell LGA and surrounding areas in the lower catchment of the Goulburn Region.
- Undertake assertive outreach to initiate and maintain contact with young people at risk of disengagement from services and community.
- Implement a range of modalities including but not limited to: intensive individual case management, group work, family work, collaboration and care planning.
- Advocate on behalf of young people in the target cohort and in consultation with other key stakeholders
- Support the development and maintenance of family relationships.
- Provide support using the case management framework.



## **POSITION DESCRIPTION**

- Provide referral and links to a range of youth services including primary health, housing, legal, justice, employment/educational and recreational activities.
- Attend relevant network meetings as requested.
- Participate in regular supervision with relevant Manager.
- Participate in relevant organisational meetings.
- Provide reports in agreed format to designated Managers.
- Adhere to The Bridge Youth Service policies and procedures.

#### **Key Selection Criteria**

- 1. A relevant tertiary qualification in youth, welfare, social work or related field (minimum Diploma level).
- 2. Experience and knowledge in the youth services field, particularly outreach and case management models, including experience in completing risk & needs assessments.
- 3. An understanding of early intervention concepts for mental health and substance misuse.
- 4. Experience in initiating, organizing, planning and implementing group sessions and other activities.
- 5. Demonstrated ability to effectively communicate, liaise, consult and negotiate with a wide range of staff, support services, education providers and service users.
- 6. Well organized with the ability to work autonomously as well as part of a team in a collaborative setting.
- 7. A passion for working with Youth.

## **Additional Requirements**

You must have a

- Current driver's licence
- Current Working with Children Check
